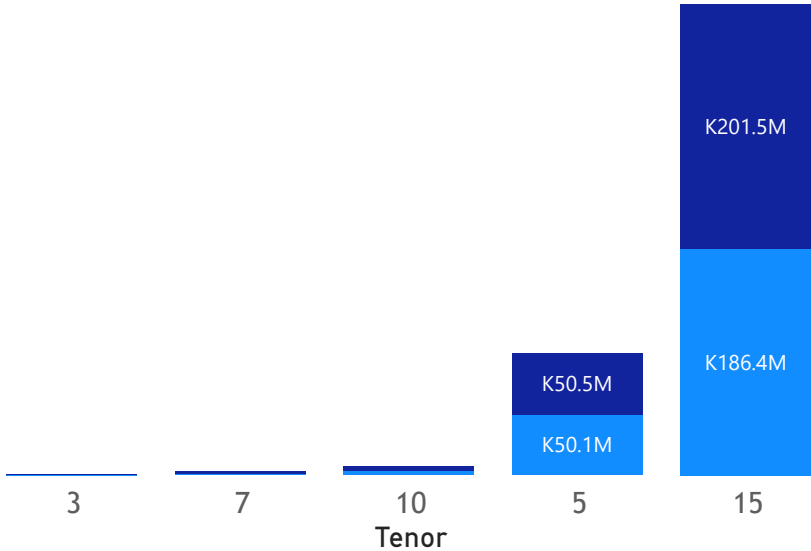

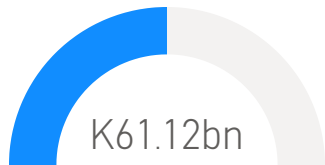

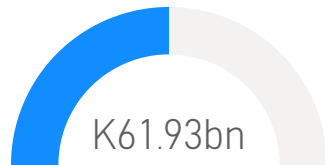

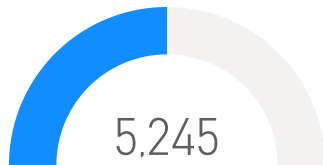
## Market Value YTD



## Nominal Value YTD

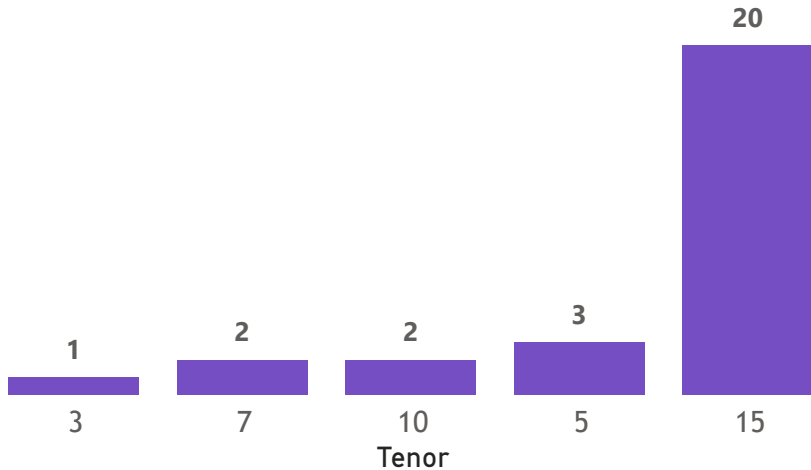


## YTD trades
